Stage II Restrictions to Lift Wednesday, August 29 Fire Danger Remains HIGH, County Burn Bans Remain

Missoula – Widespread precipitation and cool temperatures have lessened the fire danger in the Missoula Area to the extent that fire managers are able to lift fire restrictions. Since existing orders need to be rescinded as a matter of administration, restrictions will remain in effect until Wednesday, August 29th at 12:01 am. Folks in the Missoula Area will wake up on Wednesday morning with Stage II restrictions lifted. Stage I restrictions were not implemented in 2018, so Stage I restrictions will not be in effect on Wednesday.

While fire danger has lessened, fire season in the Northern Rockies in not over. Warm, dry conditions will return to the area by mid-week, and fuel moisture content of large diameter material on the forest floor will remain as available fuel for wildfires.

The public is reminded that county burn bans persist across most of western Montana. County burn bans will be lifted only when fire season is over and air quality is favorable. Debris burning is not allowed when a county burn ban is in effect. And, while campfires will be allowed on Wednesday, they should never be left unattended at any time until they are cool to the touch.

Area fire managers reported vehicle fires, trailer chains dragging that started fires, agricultural machinery, tool grinding, and unattended campfires that totaled well over a dozen fires just last week.
